## **Roles and Responsibilities of Grievances and Redressal Committee**

Without prejudice to the generality of functions mentioned, the Roles & Responsibilities of Grievance Committee is as under.

- The Grievance Redressal Committee shall consider all grievances submitted in writing or online by an individual member of the Institution regarding any injustice done to an employee/ student while discharging his/her duties at the Institution.
- The Co-ordinator shall arrange for a meeting and shall present the case before the committee for resolution. Both the complainant and the respondent need to be present along with any other person whose presence is required for the speedy resolution of the grievance.
- The Grievance Redressal Committee will study and analyze the relevant documents, the statements of complainant, respondent and witnesses, and shall discuss with those concerned and submit its recommendations to the Head of the Institution.
