### **Role and Responsibilities of Anti Ragging Squad:**

As per the guidelines of statutory bodies, an Anti-Ragging Committee has been constituted to handle issues related to ragging.

- Posters explaining anti-ragging policy of NIET are displayed around the campus, clearly stating the activities which are considered as ragging and punishments prescribed by the law for such activities. In addition, the anti-ragging policies and related details are also made available in the College Website and Student Hand Book.

- Affidavits, as per the direction from the Government and Anti-ragging undertaking are collected from all the students and their parents
- At the commencement of the academic year, through formal circular, students are instructed not to indulge in ragging and are explained about the anti-ragging policies and procedures
- Since the institution has implemented very strict policies and procedures to prevent ragging, so far, no complaints about ragging has been received either in the campus or in hostels
- CCTV cameras are also installed at various locations in the college as per the Government regulations to prevent ragging.
