#### REPORT- SEMINAR ON "SEXUAL HARRASMENT AT WORKPLACE"

DATE: 03.02.2023

Venue: Online (Google-Meet)

Seminar on "Sexual Harrasment at workplace" was conducted jointly by Internal Compliance Cell, Gender Equity Cell and Women Empowerment Cell of NIET. The seminar was conducted online through google meet. All lady faculty members (Teaching, Non-Teaching and Support staff) attended the seminar.

Mrs.D.Tharani, AP (SG) coordinated the event. Dr.R.Deepa, Head/IQAC welcomed the gathering and Dr.Shanthi, Professor, MBA proposed vote of thanks. Mr.Balamurugan with his vast experience shared the following:

The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act was passed in 2013. It defined sexual harassment, lay down the procedures for a complaint and inquiry, and the action to be taken. Under the 2013 law, sexual harassment includes "any one or more" of the following "unwelcome acts or behaviour" committed directly or by implication, Physical contact and advances, A demand or request for sexual favours, Sexually coloured remarks, Showing pornography...

Under the Act, the complaint must be made "within three months from the date of the incident". However, the ICC can "extend the time limit" if "it is satisfied that the circumstances were such which prevented the woman from filing a complaint within the said period". The ICC "may", before inquiry, and "at the request of the aggrieved woman, take steps to settle the matter between her and the respondent through conciliation" provided that "no monetary settlement shall be made as a basis of conciliation". The ICC may either forward the victim's complaint to the police, or it can start an inquiry that has to be completed within 90 days. The ICC has powers similar to those of a civil court in respect of summoning and examining any person on oath, and requiring the discovery and production of documents. When the inquiry is completed, the ICC must provide a report of its findings to the employer within 10 days. The report is also made available to both parties. The identity of the woman, respondent, witness, any information on the inquiry, recommendation and action taken, the Act states, should not be made public.

All the lady faculty members were educated about types of sexual harassment at workplace, importance of ICC and the Laws available.





## REPORT- SEMINAR ON "OBSERVANCE OF BREAST CANCER AWARENESS MONTH"

Date: 18.10.2022

Venue: Seminar Hall No.2, Ramanujam Block

Seminar on "Breast Cancer Awareness" was conducted jointly by Internal Compliance Cell, Gender Equity Cell and Women Empowerment Cell of NIET. All lady faculty members (Teaching, Non-Teaching and Support staff) and girl students attended the seminar.

The month of October is observed as Breast Cancer Awareness Month worldwide. The campaign is aimed at educating people about the importance of early screening, detection and treatment of breast cancer. According to WHO, breast cancer is by far the most common cancer in women worldwide, both in developed and developing countries and a primary cause of death of women in metropolitan cities. To support the cause, Internal Compliance Cell, Gender Equity Cell and Women Empowerment Cell of NIET organised a seminar on Breast Cancer Awareness on 18th October 2022. The speakers were Dr.Fuela Esther, Principal, Nehru Institute of Health Sciences, Coimbatore and Ms.Gayathri, Tutor, Nehru Institute of Health Sciences, Coimbatore.

Beginning with a general outlook on all types of cancers, the speaker moved on to talk about the lifestyle changes that are resulting in an increase in breast cancer cases. She highlighted the importance of regular self-inspection and clinical self examination for the early detection of breast cancer as 80% cases are detected at the advanced stage. Noting that any woman can get breast cancer irrespective of their family history, the speaker said that breast cancer can be cured if treatment is provided at the right time. She also threw light upon the symptoms of breast cancer and the preventive measures to be taken in order to reduce the risk of this disease. In the end, questions from the audience were taken up and detailed information about Breast Self-Examination (BSE) were taught to all girl students and lady faculty members
